**GOVERNOR'S WORKFORCE DEVELOPMENT DIRECTIVE NO. PY2013-09, Change 05**

**SUBJECT:** *State Reporting/Technical Assistance Guide*


**1. Purpose.** This Directive transmits the most recently (July 16, 2015) revised page Attachment A (Appendix A (A-2)) of the *State Reporting/Technical Assistance Guide*, which contains the Workforce Investment Act (WIA) Self-Sufficiency Income Level Chart, which is also applicable to the Workforce Innovation and Opportunity Act (WIOA).

**2. Discussion.** The revised Lower Living Standard Income Level (LLSIL) information was recently published (Federal Register / Vol. 80, No. 59, March 27, 2015), and required changes to the Self-Sufficiency Income Level Chart. Subsequent to this issuance, the Employment and Training Administration (ETA) discovered that the South Metro 2015 Adjusted LLSIL data was not correct. On July 16, 2015, the ETA issued (Federal Register, Vol. 80, No. 136) corrected South Metro data as well as (corrected) Table 5 updated 2015 LLSIL (100 Percent) by Family Size.

**3. Action.** Please replace the previously transmitted (GWDD No. PY2013-09, Change 03) page Attachment A (Appendix A (A-2)) in the *State Reporting/Technical Assistance Guide* with the revised Page A-2 attached to this Directive. All staff and subrecipients with participant eligibility determination-related responsibilities should be provided with this information. Note that the "Non-Metro Area data was not affected in the July 16, 2015 correction.

**These guidelines go into effect on the day they were published, March 27, 2015. The correction is also retroactive to March 27, 2015.**
