§ 40-18-411(a)(1)(d)

**INLAND PORT OR INTERMODAL FACILITY**

Under Article 19 of Chapter 18 of Title 40, *Code of Alabama 1975*, as amended, a Local Economic Development Organization (“LEDO”) may apply to have an **inland port or intermodal facility** project be considered for funding under the Growing Alabama program for capital improvements or economic development activities.

Eligible sites must be owned by the LEDO. Capital improvements include capitalized construction and rehabilitation expenses, dredging of waterways and expansion of onsite storage facilities. Economic development activities include activities and initiatives which enhance the use of, and flow of goods through, and inland port or intermodal facility.

Growing Alabama projects are funded through taxpayer contributions. Taxpayers receive an income tax credit in the amount of their contribution.
