GOVERNOR'S WORKFORCE DEVELOPMENT DIRECTIVE NO. PY2001-26, Change 9

SUBJECT: Program Year 2002 WIA Youth, Adult, and Dislocated Worker Allocations

1. **Purpose.** This transmits notice of a reduction in AWIA FY 2003 Capacity Building funds, and a corresponding increase in State-Level FY 2003 7% Other WIA Activities funds.
2. **Discussion.** Final reports indicate \$3,668.27 of AWIA FY 2003 Capacity Building funds and \$20,000 of Jefferson LWIA Capacity Building funds remain unexpended.

Pursuant to applicable WIA Fiscal Procedures Manual guidelines, these funds are recaptured from the affected LWIA. In order to facilitate their timely expenditure, these funds are re-designated as State-level "Other WIA Activities" funds.

3. **Action.** Governor's Workforce Development Directive No. PY2001-26, Attachment 1, is changed as follows:

- a. Overall, local area FY 2003 Dislocated Worker (3%) Capacity Building Grant funds are reduced by \$3,668.27. State-level FY 2003 Dislocated Worker Other WIA Activity funds are increased by \$3,668.27.

Attachment 1, page three, indicates the revised FY 2003 Local Area Capacity Building funding levels.

- b. The AWIA should submit the appropriate modifications to their PY 2003/FY 2003 Grant Agreement Packages by **December 3, 2004**.

Replace the old Attachment 1 with the new Attachment 1.
