SUBJECT: Program Year 2004 WIA Youth, Adult, and Dislocated Worker Allocations

1. **Purpose.** This transmits the USDOL Notices of Obligation reflecting the Program Year 2004 component of the PY 2004/FY 2005 Workforce Investment Act Adult, Youth, and Dislocated Worker program formula funds allotted to the State.

2. **Discussion.** USDOL Grant Agreement AA-13783-04-50, dated 7/12/2004, documents the Program Year 2004 portion of the Program Year 2004/Fiscal Year 2005 Workforce Investment Act Adult, Youth, and Dislocated Worker program funds allotted to the State.

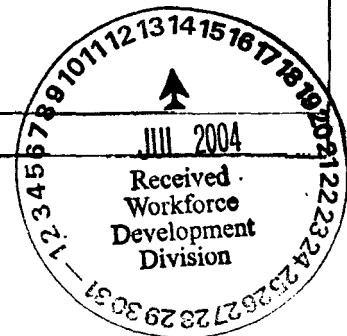
